### Siemens PLM Software Online Software Trial

### Terms of Use and Service

Last updated: October 3, 2018

Governing the use of the Siemens PLM Software Online Software Trial site, including any software, forums and file sharing services offered on it (referred to collectively as the "Services" in this document) and excluding any services provided to you by Siemens PLM Software or any of its affiliates under a separate written or electronic agreement.

#### 1. Terms

- 1.1 Your use of the Services is subject to the terms of a legal agreement between you and Siemens PLM Software. "Siemens PLM Software" means Siemens Product Lifecycle Management Software Inc., whose principal place of business is at 5800 Granite parkway, Suite 600, Plano, TX 75024, United States. This document explains how the agreement is made up, and sets out the terms of that agreement.
- 1.2 In addition to these terms, your agreement with Siemens PLM Software will also include the terms of any legal notices applicable to or presented within the Services (the "Additional Terms"). If Additional Terms apply to a Service, those terms will be accessible for you to read either within that Service, or within the site through which that Service is provisioned.
- 1.3 These terms together with the Additional Terms (the "Terms"), form a legally binding agreement between you and Siemens PLM Software in relation to your use of the Services.
- 1.4 If there is any contradiction between the Additional Terms and the Terms herein, then the Additional Terms shall take precedence with respect to the related Service to which they are applicable.
- 2. Accepting the Terms
- 2.1 You may not use the Services if you do not accept the Terms.
- 2.2 You can accept the Terms by:
- (a) clicking to accept or agree, or submit to agree, to the Terms, where the option is made available to you by Siemens PLM Software in the user interface for any Service; or
- (b) by using the Services. In this case, you understand and agree that Siemens PLM Software will treat your use of the Services as acceptance of the Terms from that point onwards.
- 2.3 You may not use the Services and may not accept the Terms if:
- (a) you are not of legal age to form a binding contract with Siemens PLM Software; or
- (b) you are a person barred from receiving the Services under the laws of the United States or other countries including the country in which you are resident or from which you use the Services.
- 2.4 Please print a copy of these terms for your records.
- 3. Provision of the Services by Siemens PLM Software

- 3.1 Siemens PLM Software has subsidiaries and affiliated legal entities around the world ("Subsidiaries and Affiliates"). Sometimes, these companies may be providing the Services to you on behalf of Siemens PLM Software itself. You acknowledge and agree that Subsidiaries and Affiliates will be entitled to provide the Services to you.
- 3.2 You acknowledge and agree that the form and nature of the Services which Siemens PLM Software provides is at Siemens PLM Software's sole discretion and may change from time to time without prior notice to you, including the cessation of the Service or some offerings within the Service.
- 3.3 The Services include temporary online trials to certain of Siemens PLM Software's software products as those software products may be made available in an online trial format by Siemens PLM Software, in its sole discretion. If not designated within the Service or while signing up for the Service, the standard period of time for an online trial is seven (7) days. You acknowledge and agree that at the end of each temporary online trial of software, you will no longer have access to the Services.
- 3.4 You may stop using the Services at any time without requirement of notification to Siemens PLM Software when you stop using the Services.
- 3.5 You acknowledge and agree that Siemens PLM Software may, at its sole discretion, disable access to your account, preventing you from accessing all or some of the Services, your account details or any files or other content which is contained in your account.
- 3.6 The online trials of software are self-contained, and you are not permitted to upload or use your own data in connection with your online trial of the software. Additionally, the Services do not permit you to backup, download, or in any way save any of the work you create while using the trial software. With that in mind, you acknowledge and agree that any configurations, designs, objects, CAD data, or any other items or objects that you create within, and while using, the online trial software cannot be backed up, downloaded, or saved in any way, and will no longer be available to you after each of your online trials of software has ended, and Siemens PLM Software is under no obligation to retain or make such information available to for you during, or after the end of, any online trial.
- 3.7 You acknowledge and agree that, if applicable, while Siemens PLM Software may not currently set a fixed upper limit on the number of transmissions you may send or receive through the Services or on the amount of storage space used for the provision of any Service, such fixed upper limits if currently set may be modified, and if not set may be set by Siemens PLM Software at any time, at Siemens PLM Software's discretion.
- 3.8 You acknowledge and agree that Siemens PLM Software may collect data and metrics about your use of the Services and may in its sole discretion use such data and metrics to improve the Services and other Siemens PLM Software products and service offerings.

### 4. Use of the Services

4.1 Access to the Services may require you to provide identification and/or contact or other information, including but not limited to your first name and last name, email address, and your geographic location. You agree that any such information you give to Siemens PLM Software will always be accurate, correct and up to date.

- 4.2 You agree to use the Services only for purposes that are permitted by:
  - (a) the Terms; and
- (b) any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions (including any laws regarding the export of data or software to and from the United States or other relevant countries).
- 4.3 You agree not to access (or attempt to access) any of the Services by any means other than through the interface that is provided by Siemens PLM Software, unless you have been specifically allowed to do so in a separate agreement with Siemens PLM Software. You specifically agree not to access (or attempt to access) any of the Services through any automated means (including use of scripts or web crawlers).
- 4.4 You agree that you will not engage in any activity that interferes with or disrupts the Services (or the servers and networks which are connected to the Services).
- 4.5 Unless you have been specifically permitted to do so in a separate agreement with Siemens PLM Software, you agree that you will not reproduce, duplicate, copy, sell, trade or resell the Services for any purpose.
- 4.6 You agree that you are solely responsible for (and that Siemens PLM Software has no responsibility to you or to any third party for) any breach of your obligations under the Terms and for the consequences (including any loss or damage which Siemens PLM Software may suffer) of any such breach.
- 4.7 You acknowledge that all information (such as data files, written text, computer software, CAD data and graphics) which you may have access to as part of, or through your use of, the Services are the sole responsibility of the person from which such content originated. All such information is referred to below as "Content".

## 4.8 You agree that you will not:

- defame, abuse, harass, stalk, threaten or otherwise violate the legal rights (such as rights of privacy and publicity) of others;
- upload, post, email or transmit or otherwise make available any inappropriate, defamatory, infringing, obscene, or unlawful Content;
- upload, post, email or transmit or otherwise make available any Content that infringes any patent, trademark, copyright, trade secret or other proprietary right of any party, unless you are the owner of such rights or have the permission of the owner to post such Content;
- upload, post, email or transmit or otherwise make available messages that promote pyramid schemes, chain letters or disruptive commercial messages or advertisements, or anything else prohibited by law, these Terms or any applicable policies or guidelines;
- download any file posted by another that you know, or reasonably should know, that cannot be legally distributed in such manner;

- impersonate another person or entity, or falsify or delete any author attributions, legal or other proper notices or proprietary designations or labels of the origin or source of software or other material;
- restrict or inhibit any other user from using and enjoying the Services;
- use the Services for any illegal or unauthorized purpose;
- submit Content that falsely expresses or implies that such Content is sponsored or endorsed by Siemens PLM Software;
- create user accounts by automated means or under false or fraudulent pretenses;
- promote or provide instructional information about illegal activities or promote physical harm or injury against any group or individual; or
- transmit any viruses, worms, defects, Trojan horses, or any items of a destructive nature.
- 5. Passwords and Account Security
- 5.1 You agree and understand that you are responsible for maintaining the confidentiality of passwords and any user credentials associated with any account you use to access the Services.
- 5.2 You agree that you will be solely responsible to Siemens PLM Software for all activities that occur under your account.
- 5.3 If you become aware of any unauthorized use of your password or user credentials of your account, you agree to notify Siemens PLM Software immediately at https://www.plm.automation.siemens.com/en/about\_us/contact/software-piracy.cfm

## 6. Privacy and Personal Information

This policy explains how Siemens PLM Software treats your personal information, and protects your privacy, when you use the Services.
- 6.2 You agree to the use of your data in accordance with the Siemens PLM Software Privacy Policy.

## 7. Content in the Services

7.1 Content presented to you as part of the Services may be protected by intellectual property rights which are owned by Siemens PLM Software, sponsors or advertisers, or other users of the Services who provided that Content. With the exception of your use of Content presented to you by Siemens PLM Software as part of the Services solely for your use of the Services, and any applicable limited rights granted to you from users who upload Content to the Services and make such Content available to you

for viewing or downloading in accordance with Section 10.2, you are not granted any other rights in this Content, and you may not modify, rent, lease, loan, sell, distribute or create derivative works based on this Content (either in whole or in part) unless you have been specifically told that you may do so by Siemens PLM Software or by the owners of that Content, in a separate agreement.

- 8.2 Unless you have agreed otherwise in writing with Siemens PLM Software, nothing in the Terms gives you a right to use any of Siemens PLM Software's trade names, trademarks, service marks, logos, or domain names.
- 8.3 Other than the limited license set forth in Section 10, if the Services are such that you are able to submit, post, share, transmit or display Content, Siemens PLM Software acknowledges and agrees that it obtains no right, title or interest from you (or your licensors) under these Terms in or to any Content that you submit, post, share, transmit or display on, or through, the Services, including any intellectual property rights which subsist in that Content (whether those rights happen to be registered or not, and wherever in the world those rights may exist). Unless you have agreed otherwise in writing with Siemens PLM Software, you agree that you are responsible for protecting and enforcing those rights and that Siemens PLM Software has no obligation to do so on your behalf.
- 8.4 You agree that you shall not add misleading proprietary rights notices to or remove, obscure, or alter any proprietary rights notices (including copyright and trade mark notices) which may be affixed to or contained within the Services or Content licensed from the Services under these Terms.

### 9. License from Siemens PLM Software

9.1 Siemens PLM Software gives you a limited-in-time, personal, worldwide, royalty-free, non-assignable and non-exclusive license to use the software provided to you by Siemens PLM Software as part of the Services as provided to you by Siemens PLM Software (referred to as the "Software" below). This license is for the sole purpose of enabling you to use and enjoy the benefit of the Services as provided by Siemens

PLM Software, during the limited period of time provided for the online trial, and in the manner permitted by the Terms.

9.2 You may not (and you may not permit anyone else to) assign (or grant a sub-license of) your rights to use the Software, grant a security interest in or over your rights to use the Software, or otherwise transfer any part of your rights to use the Software, copy, modify, create a derivative work of, reverse engineer, decompile or otherwise attempt to extract the source code of the Software or any part thereof, unless this is expressly permitted or required by law, or unless you have a separate written agreement with Siemens PLM Software authorizing you to do so.

#### 10. Content License

- 10.1 If the Services make it possible for you to submit, post, share, transmit, or display Content, then by submitting, posting, sharing, transmitting or displaying Content on, or through, the Services, you give Siemens PLM Software a perpetual, sublicensable, irrevocable, worldwide, royalty-free, and non-exclusive license to reproduce, adapt, modify, translate, publish, publicly perform, publicly display, query, and distribute that Content or derivative works thereof for the purpose of enabling Siemens PLM Software to display, distribute, promote, and improve the Services and other Siemens product and service offerings and such license may be revoked for certain Services as defined in the Additional Terms of those Services. This license to Siemens PLM Software includes the right for Siemens PLM Software to make such Content available to other companies, organizations or individuals with whom Siemens PLM Software has relationships for the provision of syndicated services, and to use such Content in connection with the provision of those services. - 10.2 If the Services make it possible for you to make Content available to other end users for viewing, then by making Content available to other end users for viewing on, or through, the Services, you give such other end users of the Services a worldwide, royalty-free, and non-exclusive license to view (subject to the restrictions set forth in Section 10.3 and 15.3 of these Terms) any such Content on, or through, the Services. Furthermore, by making the Content available to other end users for download on, or through, the Service, you give such other end users of the Services a perpetual, sublicensable, irrevocable, worldwide, royalty-free, and non-exclusive license to possess and use (subject to the restrictions set forth in Sections 10.3 and 15.3 of these Terms) such downloaded Content.
- 10.3 Notwithstanding anything to the contrary, without Siemens PLM Software's prior authorization, you may not aggregate Content obtained from Siemens PLM Software Services for redistribution.
- 10.4 You confirm and warrant to Siemens PLM Software that you have all the rights, power and authority necessary to grant any applicable licenses above.

## 11. INDEMNITY.

You agree to hold harmless and indemnify Siemens PLM Software, and its subsidiaries, affiliates, officers, agents, and employees, advertisers or partners, from and against any third party claim (including but not limited to claims brought by other users of the Services) arising from or in any way related to your use of

the Services, violation of these Terms or any other actions connected with use of the Services, including any liability or expense arising from all claims, losses, damages (actual and consequential), suits, judgments, litigation costs and attorneys' fees, of every kind and nature. In such a case, Siemens PLM Software will provide you with written notice of such claim, suit or action.

## 12. EXCLUSION OF WARRANTIES

- 12.1 NOTHING IN THESE TERMS, INCLUDING SECTIONS 12 AND 13, SHALL EXCLUDE OR LIMIT SIEMENS PLM SOFTWARE'S WARRANTY OR LIABILITY FOR LOSSES WHICH MAY NOT BE LAWFULLY EXCLUDED OR LIMITED BY APPLICABLE LAW. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES OR CONDITIONS OR THE LIMITATION OR EXCLUSION OF LIABILITY FOR LOSS OR DAMAGE CAUSED BY NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF IMPLIED TERMS, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES. ACCORDINGLY, ONLY THE LIMITATIONS WHICH ARE LAWFUL IN YOUR JURISDICTION WILL APPLY TO YOU AND OUR LIABILITY WILL BE LIMITED TO THE MAXIMUM EXTENT PERMITTED BY LAW.
- 12.2 YOU EXPRESSLY UNDERSTAND AND AGREE THAT YOUR USE OF THE SERVICES IS AT YOUR SOLE RISK AND THAT THE SERVICES ARE PROVIDED "AS IS" AND "AS AVAILABLE."
- 12.3 IN PARTICULAR, SIEMENS PLM SOFTWARE, ITS SUBSIDIARIES AND AFFILIATES, AND ITS LICENSORS DO NOT REPRESENT OR WARRANT TO YOU THAT: (A) YOUR USE OF THE SERVICES WILL MEET YOUR REQUIREMENTS, (B) YOUR USE OF THE SERVICES WILL BE UNINTERRUPTED, TIMELY, SECURE OR FREE FROM ERROR, (C) ANY INFORMATION OBTAINED BY YOU AS A RESULT OF YOUR USE OF THE SERVICES WILL BE ACCURATE OR RELIABLE, (D) THAT DEFECTS IN THE OPERATION OR FUNCTIONALITY OF ANY SOFTWARE PROVIDED TO YOU AS PART OF THE SERVICES WILL BE CORRECTED, AND (E) THE QUALITY OF ANY PRODUCTS, SERVICES, INFORMATION, OR OTHER MATERIAL PURCHASED OR OBTAINED BY YOU THROUGH THE SERVICES WILL MEET YOUR EXPECTATIONS.
- 12.4 ANY MATERIAL DOWNLOADED OR OTHERWISE OBTAINED THROUGH THE USE OF THE SERVICES IS DONE AT YOUR OWN DISCRETION AND RISK AND YOU WILL BE SOLELY RESPONSIBLE FOR ANY DAMAGE TO YOUR COMPUTER SYSTEM OR OTHER DEVICE OR LOSS OF DATA THAT RESULTS FROM THE DOWNLOAD OF ANY SUCH MATERIAL.
- 12.5 NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED BY YOU FROM SIEMENS PLM SOFTWARE OR THROUGH OR FROM THE SERVICES SHALL CREATE ANY WARRANTY NOT EXPRESSLY STATED IN THE TERMS.
- 12.6 SIEMENS PLM SOFTWARE FURTHER EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

# 13. LIMITATION OF LIABILITY

13.1 SUBJECT TO OVERALL PROVISION IN PARAGRAPH 12.1 ABOVE, YOU EXPRESSLY UNDERSTAND AND AGREE THAT SIEMENS PLM SOFTWARE, ITS SUBSIDIARIES AND AFFILIATES, AND ITS LICENSORS SHALL NOT BE LIABLE TO YOU FOR:

- (A) ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL CONSEQUENTIAL OR EXEMPLARY DAMAGES WHICH MAY BE INCURRED BY YOU, HOWEVER CAUSED AND UNDER ANY THEORY OF LIABILITY, INCLUDING BUT NOT LIMITED TO, ANY LOSS OF PROFIT (WHETHER INCURRED DIRECTLY OR INDIRECTLY), ANY LOSS OF GOODWILL OR BUSINESS REPUTATION, ANY LOSS OF DATA SUFFERED, COST OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES, OR OTHER INTANGIBLE LOSS; RESULTING FROM: (I) THE USE OR THE INABILITY TO USE THE SERVICES; (II) UNAUTHORIZED ACCESS TO OR ALTERATION OF YOUR TRANSMISSIONS OR DATA; (III) STATEMENTS OR CONDUCT OF ANY THIRD PARTY ON THE SERVICES; OR (IV) ANY OTHER MATTER RELATING TO THE SERVICES;
- (B) ANY LOSS OR DAMAGE WHICH MAY BE INCURRED BY YOU, INCLUDING BUT NOT LIMITED TO LOSS OR DAMAGE AS A RESULT OF: (I) ANY CHANGES WHICH SIEMENS PLM SOFTWARE MAY MAKE TO THE SERVICES, OR FOR ANY PERMANENT OR TEMPORARY CESSATION IN THE PROVISION OF THE SERVICES (OR ANY FEATURES WITHIN THE SERVICES); (III) THE DELETION OF, CORRUPTION OF, OR FAILURE TO STORE, ANY CONTENT AND OTHER COMMUNICATIONS DATA MAINTAINED OR TRANSMITTED BY OR THROUGH YOUR USE OF THE SERVICES; (III) YOUR FAILURE TO PROVIDE SIEMENS PLM SOFTWARE WITH ACCURATE ACCOUNT INFORMATION; (IV) YOUR FAILURE TO KEEP YOUR PASSWORD OR ACCOUNT DETAILS SECURE AND CONFIDENTIAL.
- 13.2 THE LIMITATIONS ON SIEMENS PLM SOFTWARE'S LIABILITY TO YOU IN PARAGRAPH 13.1 ABOVE SHALL APPLY WHETHER OR NOT SIEMENS PLM SOFTWARE HAS BEEN ADVISED OF OR SHOULD HAVE BEEN AWARE OF THE POSSIBILITY OF ANY SUCH LOSSES ARISING.

## 14. Copyright and Trademark Policies

- 14.1 It is Siemens PLM Software's policy to respond to notices of alleged copyright infringement that comply with applicable international intellectual property law (including, in the United States, the Digital Millennium Copyright Act) and to terminate the accounts of repeat infringers.
- 14.3 By submitting Content through the Services, you authorize Siemens PLM Software to use your trademarks, service marks, trade names, proprietary logos, domain names and any other source or business identifiers in connection with Siemens PLM Software's authorized distribution of Content, including for promotional purposes.

# 15. Other Content

- 15.1 The Services may include hyperlinks to other web sites or content or resources. Siemens PLM Software may have no control over any web sites or resources which are provided by companies or persons other than Siemens PLM Software.
- 15.2 You acknowledge and agree that Siemens PLM Software is not responsible for the availability of any such external sites or resources, and does not endorse any advertising, products or other materials on or available from such web sites or resources.
- 15.3 You acknowledge and agree that Siemens PLM Software is not liable for any loss or damage which may be incurred by you as a result of the availability of those external sites or resources, or as a result of any reliance placed by you on the completeness, accuracy or existence of any advertising, products or other materials on, or available from, such web sites or resources.

# 16. Changes to the Terms

- 16.1 Siemens PLM Software may make changes to the Terms from time to time. When these changes are made, Siemens PLM Software will make a copy of the updated Terms available for your review at the trial signup page and/or from within the Services.
- 16.2 You understand and agree that if you use the Services after the date on which the Terms have changed, Siemens PLM Software will treat your use as acceptance of the updated Terms.

# 17. General legal terms

- 17.1 The Terms constitute the whole legal agreement between you and Siemens PLM Software and govern your use of the Services and completely replace any prior agreements between you and Siemens PLM Software in relation to the Services.
- 17.2 You agree that Siemens PLM Software may provide you with notices, including those regarding changes to the Terms, by email, regular mail, or postings on the Services.
- 17.3 You agree that Siemens PLM Software's failure to exercise or enforce any legal right or remedy which is contained in the Terms (or which Siemens PLM Software has the benefit of under any applicable law is not a formal waiver of Siemens PLM Software's rights and that those rights or remedies will still be available to Siemens PLM Software.
- 17.4 If any court of law, having the jurisdiction to decide on this matter, rules that any provision of these Terms is invalid, then that provision will be removed from the Terms without affecting the rest of the Terms. The remaining provisions of the Terms will continue to be valid and enforceable.
- 17.5 You acknowledge and agree that each member of the group of companies of which Siemens PLM Software is an affiliate shall be third party beneficiaries to the Terms and that such other companies shall be entitled to directly enforce, and rely upon, any provision of the Terms which confers a benefit on (or rights in favor of) them. Other than this, no other person or company shall be third party beneficiaries to the Terms.
- 17.6 The Terms, and your relationship with Siemens PLM Software under the Terms, shall be governed by the laws of the State of Texas without regard to its conflict of laws provisions. Notwithstanding the foregoing, you agree that Siemens PLM Software shall still be allowed to apply for injunctive remedies (or an equivalent type of urgent legal relief) in any jurisdiction.
